**PRESS NOTICE**

Sealed tenders are invited by the President, Sri Manakulavinayagar Devasthanam, Puducherry, for the following works from the eligible contractors/firms. Contractors other than those registered with P.W.D, Puducherry should produce documentary evidence in support of their having satisfactorily completed three similar works each of **40%** of estimate cost put to tender or two works each of **60%** of estimate cost put to tender or one work of **80%** of estimate cost put to tender in the last **seven years ending previous day of last date of submission of tenders**. (Similar work means execution of '**BUILDING WORKS**'). The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for tenders (for Sl. No.1).

Tender will be received by the President, Sri Manakulavinayagar Devasthanam, Puducherry as per date and time mentioned above. The tender schedule shall be dropped in the **"TENDER BOX"** kept at the Temple Office.

The President, Sri Manakulavinayagar Devasthanam, Puducherry may reserves the right to change the opening time and date as mentioned above.

Tender forms and conditions of contract can be had from the office of the President, Sri Manakulavinayagar Devasthanam, Puducherry on payment of ₹ 1000/- and ₹ 500/- **respectively for works mentioned above plus GST @ 5%** by cash as cost of tender (Non - Refundable).


The Earnest Money should be deposited by receipt of Treasury Challan/Deposit at call receipt of a Scheduled bank/Fixed Deposit receipts of a scheduled bank/Demand Draft of a Scheduled bank and submitted along with the application requesting the tender schedule. The Earnest Money should be drawn in favour of President, Sri Manakulavinayagar Devasthanam, Puducherry.

The contractor who had purchased the tender schedule shall submit tender in two envelopes sealed in a single cover. The first envelope shall be placed with the copy of receipt of cost of tender schedule, proof of documents for remittance of EMD while purchasing the tender schedule, copies of eligibility for having completed satisfactorily the required number of works and the list of works on hand and the envelope shall be superscribed as "EMD/cost of Schedule" and in the other envelope superscribing "Tender Schedule" wherein the duly filled NIT shall be placed and sealed.

On the scheduled date of opening, the tender schedules of the contractor who had purchased the Tender Schedules from the office, the cover superscribing "EMD/Cost of Schedule" shall be opened first and on fulfillment of furnishing the details of cost of tender schedule/payment of EMD/eligibilities/list of works on hand as mentioned above, only the other envelope superscribing as "Tender Schedule" will be opened. The contractor's envelope "Tenders Schedule" who do not satisfy the Tender Notice conditions will be returned unopened.

If the opening day of tender happens to be a Public Holiday the same will be opened on next working day.

The time allowed for carrying out the work will be column No.7 including monsoon period from the tenth day after the date of written order to commence the work.
